1. Skipped item one: December 4, 2019 minutes

2. Motion amending: Member Bell: I make a motion to amend the number 1 item on the November 6 (,2019) minutes, to approve September 4 change that to October 2.

3. Up-date on: Ben Gudmunson's house re-model:

I did learn a lot of things, Ben had to stop demoing the house as he is fixing it up to re-sale it and he is not a licensed contractor.

There was more discussion including about splitting the parcel.

4. Mariah Huggins: building permit, Mrs. Huggins presented the committee with her information lot layout with setbacks, home design, and letter from the health department; she stated that because of the

holidays Mark was unable to get the permit for the septic finished but that he will have it after the New Years.

Member Bell: Asked about how far away from the well she had to go.

Mariah Huggins: Provided a lot of detailed information about the distance and how every lot will be different dependant on ground saturation, soil type and topographical layout.

Member Bell: Said we know now for the future that we tell them that they need to talk to Mark at the health department and bring the information to us.

Member John: That the committee has talked about this before and that is why she wants to add this to the Water Protection Zone in the ordinances.

Member John: made a note on Mrs. Huggins building permit about the setbacks distances so the permit is ready for town council next week.

Mariah Huggins: wanted to pay her water fees, she was informed that we cannot take any form of payment and she will need to come and make a payment to the treasure Debbie Lucas and other information regarding her permit.

Motion: Member Bingham motioned to approve the building permit for Mariah Huggins Second Member Bell

Chairman John called for a vote: all ayes

Committee member stated: that there needs to be numbers not dots or bullets on the agenda items. This will be looked into and corrected.
